RESOLVED that the minutes of the last regular meeting of Council held on Tuesday July 10<sup>th</sup>, 2012 be taken as read and approved, all statutory requirements having been fulfilled.

RESOLVED that the Council of the Rural Municipality of South Cypress renew the agreement with Manitoba Association for Resource Recovery Corporation and agree to the terms and conditions in the two year agreement commencing August 1<sup>st</sup>, 2012 to July 31<sup>st</sup>, 2014.

RESOLVED that the Council of the Rural Municipality of South Cypress authorize Swansfleet Alliance of Bruxelles, Manitoba to install and bury, at an appropriate depth, a 12" water irrigation pipeline in/under the Municipal road between SE ¼ of Section 8; Township 7; Range 14WPM and the NE ¼ of Section 5; Township 7; Range 14WPM and the Municipal road between SW ¼ of Section 5; Township 7; Range 14WPM and the SE ¼ of Section 6; Township 7; Range 14WPM;

AND FURTHER BE IT RESOLVED that all necessary installation work and materials be the responsibility of the applicant with the completed installation to meet the approval of the Ward Councillor and furthermore that the applicant, as may be prescribed by the Municipality, be required to repair, maintain, relocate and improve such irrigation pipeline in a safe and workmanship fashion all which shall be at the sole and exclusive cost of the applicant;

AND FURTHER BE IT RESOLVED that the applicant acquire a "Right of Way in a Municipal Road" Development Permit for the said installation.

AND FURTHER BE IT RESOLVED that the said installation approval be subject to the condition that the applicant, at his cost, attend to in due course, duly executed agreement, easement and respective signage for the affected roads.

Whereas Brad Vertz, applicant for Mary Thacker, the owner of the property legally described as part SE 34-7-14W and located approximately 3 miles north and ½ mile west of the intersection of Highways #5 & #2 in the R. M. of South Cypress, applied to the Council of the R. M. of South Cypress for approval of a Conditional Use order under Zoning By-law No. 1485, Part IV, Section 6, Table IV-I, in order to:

Establish a Single Family Rural Non-Farm Dwelling Site in an "AG-Agricultural General Rural District" (990' wide x 440' deep - 10 Acres).

And after careful consideration of the application and any representations made for or against it, the Council of the R. M. of South Cypress in a meeting duly assembled on the 14<sup>th</sup> day of August AD., 2012.

APPROVED the said application.

AND FURTHER BE IT RESOLVED that the crushing of the said 20,000 cubic yards of gravel be undertaken this fall, at the contractors choice/convenience, and accordingly billing and payment of same be deferred to January 31, 2013.
